CDR Lashley "Lash" Hatch currently serves as a Commissioned Corps Liaison for the Indian Health Service, overseeing over 400 Corps officers from all categories in the Navajo and Phoenix Areas.

CDR Hatch served as a Voting member for PharmPAC from 2019-2022. He served as Admin Chair and oversaw the Annual Report and the Honor Award program, including the creation of a new Junior Pharmacist Award. In the past, he has served in JOAG as awards historian and COF Symposium Pharmacy Category Day Committee. He has presented numerous times on national, regional and local levels including AMSUS and the IHS Southwest Regional Continuing Pharmacy Education Meeting.

CDR Hatch attended the University of Arizona where he received his Doctor of Pharmacy degree.
